The letter features a standard form because it must satisfy all the GDPR requirements as laid out in Article 34 of the legislation, Communication of a personal data breach to the data subject .

## **NOTIFICATION OF DATA SECURITY INCIDENT**

When providing substitute notice, the covered entity must also include, in the HIPAA breach notification letter, a toll-free phone number that remains active for at least 90 days, where an individual can learn whether the individual's unsecured protected health
