One in four farmers committing suicide are in debt. As many as 8,007 Indian farmers committed suicide in 2015, an increase of 41.7% from 5,650 in 2014, and 39% of farmers who died in this manner were in debt, according to 2015 National Crime Records Bureau data, the latest available. In 2014, 20.6% of farmers who killed themselves had borrowed money.
